14/426 Community Festival 2015 – Sunday 26 July 2015

iii) *Cemetery Chapel Open Afternoon*

The Chairman reminded Members that the Parish Council had contacted Maldon District Council regarding the poor state of repair of the Chapel. The Council wrote to MDC regarding the

Chapel and they responded that maintenance works have been scheduled for the Chapel. The Chairman recently inspected the Chapel and no maintenance works had taken place. The Chairman will be contacting MDC Cemetery Officer.

It was noted that a Chapel drop-in event would be of benefit for the community. It was also noted that local community groups such as Heybridge Neighbourhood Group and Residents Association might be interested in helping to clean up the Chapel.
