Cllr Prof Schnurr informed Members that a provisional meeting had been arranged with the owner of the Church and their agent to discuss the application. It had been suggested that Cllr Lawson attend the meeting along with Cllr Prof Schnurr. There was a lengthy discussion which raised various concerns. Following the discussion, it was agreed to have a recorded vote on whether the meeting should take place to simply listen to the owner of the Church and their agent as to the details of the planning application.

16/261 Marine Planning

- Members received an update from Mr. Lankester. It was noted that:-
 - Mr Lankester had opened up a dialogue with the Local Access Forum. There was a concern regarding the maritime assets inventory in Tollesbury especially the issues raised of level of disturbance by recreational boat users. There had been a suggestion to put in place a blanket ban to not allow access to the land from the water which would alleviate any recreational boat use.
 - The heritage of salt marshes could be effected.
 - The Planning Advisory Service has issued soundness selfassessment check lists which include:
 - Integration of terrestrial and marine
 - Recognition of importance of marine tourism
 - Increase in local economy
 - The House of Commons are currently discussing future flood prevention. They are recommending that large areas of farm land should be set aside for flood plains. It was suggested that this would have an effect on the agricultural policy.

 It was noted in the Local Development Plan that fluvial flooding was the responsibility of the Environment Agency and that pluvial flooding was the responsibility of the District Council.

16/262 Neighbourhood Plan Task and Finish Working Group

Cllr Prof Schnurr thanked everyone who helped with the public workshop held on Sunday 23rd October 2016. It was noted that 34 people had attended the workshop. The comments received were to be summarised and made available for the next working group meeting.

There was a general discussion and a suggestion to investigate the costs of a professional consultant.

The next working group meeting will be held on Tuesday 15th November 2016 at 7.00pm. The meeting will focus on developing a vision statement. It was noted that maps of Heybridge and aerial photos would be of benefit.
